In consideration of the MSC, Inc. allowing my participation in this event, I on behalf of myself and my heir, administrators, personal representatives, assigns and children and spouse, if any, do hereby agree to hold harmless, release and discharge MSC, Inc. which includes its officers, director, members, agents, representatives, affiliates and insurers, of and from all claims, demands, causes of action and legal liability whether known or unknown, anticipated or unanticipated due to the ordinary negligence of MSC Inc. for any damage or loss due to bodily injury, death or property damage arising out of my participation in this event.
